
On April 8th, 2023, the PG Department of Business Administration organised a guest lecture by resource person Dr. Mallikarjunappa, Professor, Justice K S Hegde Institute of Management, Nitte. The session began with the welcome and introduction by the MC Ms. Nithya R.S of I Semester MBA, A Batch and welcome and introduction of the Resource person Dr T Mallikarjunappa by Ms Fiza of I MBA, B Batch.

Objectives of the session:

- 1. To familiarise the students with the nuances of International Financial Reporting Standards and how they are relevant in preparing financial statements.
- 2. To enable the students to pursue a career in international accounting by acquainting them with the practical applications of the same.



He spoke about the meaning of International Financial Reporting Standards (IFRS) and their relevance. The lecture began at 11:00 am and covered various aspects related to IFRS. The session was attended by I Semester students and faculties of PG Department of Business Administration.

The session began with an introduction to financial statements and various types of accounts that are included in them. Dr. Mallikarjunappa explained the importance of financial statements in providing information to its users on the financial health of a company. The lecture then moved on to the need for IFRS, which are a set of accounting standards used globally. He also explained to the students how global companies can get affected without proper accounting standards, and how it could lead to challenges in cross-border transactions. He further explained how accounting standards were formed and how they evolved over time. He highlighted the importance of having a single set of accounting standards that can be used across borders and how IFRS helps in achieving this goal.



The lecture also covered the Norwalk Agreement, which was signed in 2002 between the International Accounting Standards Board (IASB) and the Financial Accounting Standards Board (FASB) of the United States. The agreement aimed to converge US Generally Accepted Accounting Principles (GAAP) with IFRS, to reduce differences between the two accounting frameworks. Dr. Mallikarjunappa also discussed the Indian Accounting Standards (Ind AS) and emphasized the importance of adopting global accounting standards like IFRS, to ensure that Indian companies can compete globally and to make financial reporting more transparent and reliable. Finally, the lecture covered the difference between IFRS and International Accounting Standards (IAS), which were the earlier set of accounting standards. Dr. Mallikarjunappa explained how IFRS has evolved from IAS and how it is a more comprehensive set of accounting standards.

The session came to an end with the vote of thanks proposed by Ms Shreya Kava of I MBA, A Batch. Overall, the lecture was informative and insightful. 99 students of I year MBA benefitted from the session.




