#### ABSTRACT

The Site of the Four-Lane divided Project Highway comprises the section of National Highway: 66 commencing from Km 93.700 to Km 283.300 i.e. the Goa-Karnataka border Kundapur section in the State of Karnataka. Site of the Four-Lane Project Highwa, shall include the land, buildings, structures and road works as described in the given Schedule.

An inventory of the Site including the land, buildings, structures, road works, trees and any other immovable property on, or attached to, the Site shall be prepared jointly by the Authority Representative and the Concessionaire.

Additional land required for Toll Plazas, Traffic Aid Posts, Medical Aid Posts and vehicle rescue posts or for construction of works specified in the Change of Scope Order issued. The scope of the Project (the "Scope of the Project") shall mean and include, during the Concession Period:

- (a) Construction of the Project Highway on the Site set forth in Schedules and as specified together with provision of Project Facilities as specified in Schedule, and in conformity with the Specifications and Standards set forth in Schedule.
- (b) Operation and maintenance of the Project Highway in accordance with the provisions of this Agreement; and
- (c) Performance and fulfilment of all other obligations of the Concessionaire in accordance with the provisions of this Agreement and matters incidental thereto or necessary for the performance of any or all of the obligations of the Concessionaire under this Agreement.




Figure 1.1 Index of the Indian National Highway Network Map




Figure 1.2 Location Map of the Road
