

accreditation process registration is must for all the institution including the institution already have NAAC score and entering in the process of Re accreditation. He told about the documents required from the institute required for the process filing. He elaborated the process and preparation required for NAAC accreditation. In his talk he highlighted all the key indicators in brief. All the new introduced key indicators such Teacher Profile and Quality, Student Satisfaction Survey, Innovation Ecosystem, Alumni Engagement, Institutional Values and Social Responsibilities, Institutional Distinctiveness were notified in his talk. He suggested reading the NAAC manuals and documents carefully before filing the accreditation process. He also emphasized on the importance of the good health of the all the faculty members specially IQAC manner so that everyone can contribute at their best in the upliftment and growth of the institution.

Once Self Study Report is submitted, DVV Partner is assigned randomly to the institute for verification and validation. Verification of information can be done through external sources too. He gave details of the Data Validation and Verification Process. He explained the process adopted by NAAC for validation of data. IF DVV Partner is not satisfied by the provided data, it may ask for explanation. HEIs need to provide clarification within 15 days. NAAC provides detail Deviation Analysis Report to the HEIs for their ready reference. Non Compliance of DVV Process will lead to cancellation of assessment process. Stakeholders need to remember that the limit of document is 5 MB.

Data Validation and verification is an important aspect for the NAAC accreditation. He ellobrated about DVV process, standard operating procedures for DVV in ascertaining and validating the authenticity of submitted data and corresponding award of points to quantitative metrics. He told that DVV is only for the quantitative metric so all the supporting documents are very important to attach with to score good in these metrics. He clarified the doubts raised by the participants at the end of the session. The program concluded with the vote of thanks by Prof. Hemanth Suvarna
