

EXECUTIVE SUMMARY

This project report, titled "A Study on working capital Management at Delta Packaging Solutions Pvt Ltd, Moodbidri" focuses on the processes involved in managing inventory, manage its day-to-day operations, such as purchasing raw materials, paying suppliers, covering operational costs, and maintaining inventory.

The study was conducted over a six-week period, utilizing techniques and tools such as ratio analysis, and regression analysis to evaluate working capital management.

The report is divided into five sections. The first chapter provides an introduction to the topic, along with an overview of the industry and a description of the company. The second section delves into the theoretical background of inventory management and includes a literature review of 25 studies related to the topic, offering insights into various perspectives and findings from previous research.

In the fourth section, the collected data is analysed and interpreted using charts and figures. The final section presents the key findings, recommendations, and conclusions of the study. The research highlights the critical role of inventory management in a business, demonstrating the advantages and disadvantages of both overstocking and understocking inventory
