Following are the terms of Internship:

- 1. Scope of internship: you will go through rigorous training, and you are expected to do project assigned as part of the internship.
- 2. Your employment offer is subjected to you completing your Degree/Masters program successfully and producing the proof of the same. It is also subjected to availability of a position within the organisation. (Please refer Annexure I which shall be the compensation to be offered in case of an offer of employment ("Trainee" Position) made to you which is contingent upon point number 7 mentioned herein)
- 3. Internship timings are from 9 AM to 6 PM from Monday to Thursday at our Mangalore office premises.
- 4. Unauthorized absence from internship: Your unauthorized absence from attending internship / training for a continuous period of more than three days without prior approval from your manager, it will be treated as absconding from training, and in the event that you do not report for training within five days from the date of absence, it will be treated as "voluntary abandonment of internship" and shall be deemed that you are no longer interested in internship and subsequent employment.
- 5. Location during Internship: Your place of internship will be Mangalore and subsequent employment will be the Mangalore/Bangalore office of CodeCraft.
- 6. Location once you are employed: You will be placed either in Mangalore or Bangalore office base location. During the tenure of your service, you may be relocated/transferred to Company's Projects in India or abroad or subsidiary companies based on the business requirements.



- 7. Position availability: The final confirmation of your employment is subject to successful completion of the assessment process during the internship period and availability of a suitable position within the company.
- 8. Termination of Employment: Your employment will be subject to background verification, as per the company's hiring policy. Any misrepresentation of facts or falsification will lead to immediate termination of employment.
- 9. Employment Service Bond: On the successful completion of your assessment and availability of a position within the organisation, an offer for employment would be issued to you subject to you agreeing to work for the company for minimum of 2 years from the Date of Joining.
