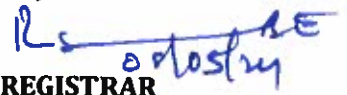

03	<b>Academic autonomy to University Departments and its programmes</b>	
<b>Recommendation</b>	<p>After detailed discussion, the committee opined that the University has academic autonomy, by virtue of which the University Departments of Studies also have academic autonomy, and hence the question of granting autonomy by the University to the Departments also does not arise. In fact, the academic autonomy could only be conferred by UGC to an <i>eligible</i> Higher Educational Institution after following due processes and the University, instead of explicitly conferring autonomy to the Department, may review the request and after assessment by an external expert committee follow due processes to permit the Departments to function independently within the framework of applicable Statutes/Regulations and the approval from the Statutory Bodies. Hence, resolved as below:</p> <ol style="list-style-type: none"> <li>1. As a onetime measure, the VTU department shall return to earlier system of functioning and equivalence of I semester curriculum shall be established with the University approved curriculum for the corresponding programmes of the affiliated institutions.</li> <li>2. As per Sl. No. 1 above, the students studying the VTU departments after reverting back to curricullam of affiliated system are eligible for award of VTU ranks.</li> <li>3.
