


## 6. Any other topics for the development of the college.

Dr. Peter Fernandes, Principal & Member Secretary, warmly welcomed the members to the meeting. Before starting with the discussion of the agenda, Principal brought to the notice of the members about the sad demise of Sri. Ananda Alva, father of Chairman Sri M Mohan Alva. A minute silence was observed to express the condolences before the meeting.

Further in the meeting following points were discussed as per the agenda.

### 1. List of students with attendance shortage to take up Feb/March 2024 exams.

Principal brought to the notice of the GC members that very few students were highly irregular to the classes. These students were contacted regularly and the information was sent to parents regarding their absence. Still the students were not able to satisfy the VTU norms to take up the semester examination. Hence the students' names were submitted to the University and were not eligible to take up the semester examination. The list of the same is attached in the annexure.

### 2. Faculty recruitment and promotion of eligible faculty.

Principal explained the GC about the need of faculty due to the introduction of new branches and also good number of admission. Members suggested to go ahead with the interview and recruitment process as and when there is requirement of teaching and non-teaching staff.

## 3. Request for increase in intake of CSE and AIML Branches.

Principal brought to the notice of the members about the high demand for the IT related branches at present. The present intake for the course is 180 and AIML branch intake is 60. Principal requested to give permission to request VTU to increase CSE intake to 240 and AIML intake to 120. By looking at the high demand for course, the members permitted for the increase in intake for the course.

## 4. Any other topics for the development of the college.

Principal explained various measures planned to improve the admission status in the college. Governing council gave inputs to improve the admission in coming years. Also

principal forwarded the request letter to initiate the process of quarterly internal auditing and external auditing for year 2024-25 for the Engineering College. Chairman forwarded the request to the Finance officer for further process.

Principal expressed his happiness to bring to the notice of the members that the college has received the approval for the autonomous status from UGC and college underwent the inspection process by the members of university for the approval of autonomous status. The committee recommended for the autonomous status and the papers were forwarded for further process.

The members congratulated the team for the efforts to obtain the autonomous status.

Finally, GC meeting was concluded with vote of thanks by the principal.
