The programs have been granted accreditation for further 3 years. **Alva's Institute of Engineering & Technology, Shobhavana Campus, Mijar, Moodbidri, Karnataka-574227** should submit fresh online application under First Cycle SAR Tier II June 2015 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
