'Alvas MBA College', a unit of 'Alvas Education Foundation', at Moodabidri, Karnataka, referred to as "Alvas MBA College", of the **SECOND PART** represented by its Principal and Authorized signatory _____;

AND WHEREAS 'BACCE - Transformation Through Values', to reach out to the 'generation next' of India, offers a series of seminars, workshops, conferences and symposiums on various topics such as IQ-EQ-SQ values, character traits, Secrets of Success and much more. These workshops are designed to empower the students and faculty to face the challenges posed in current scenarios. It offers simple, practical and relevant solutions packaged in a youthfriendly manner. The predominant focus on the present batch of students being 'Pre-Placement Training Course' designed to be delivered to the final year MBA students.

WHEREAS, 'Alvas MBA College' is on a mission to set up a centre for excellence by offering world class education in 'Business Administration' domain and research opportunities of very high standards and making students scientifically the best, ethically strong and competent in all domains of knowledge.

AND WHEREAS 'Alvas MBA College', aspires to involve BACCE to achieve its mission to produce proficient graduates with proficiency in 'Quantitative Aptitude', 'Verbal Ability', 'Logical Reasoning' and 'Industrial Soft Skills'


