Scope

This MoU is entered into on the <u>14th</u> day of <u>December</u>, <u>2017</u> by and between <u>ICAR-Krishi Vigyan Kendra</u> (hereinafter referred as KVK), of Dakshina Kannada District, situated at Fisheries College Campus, Kankanady, Mangalore

And

Alva's Institute of Engineering and Technology (hereinafter referred as AIET), a reputed Engineering institution affiliated to Visvesvaraya Technological University(VTU) - Belgaum, located at Moodbidri, Mangalore. The aforesaid institutions are hereinafter referred to individually as *institute* and collectively as *institutes*.

1. Objectives of the MOU

The objectives of the MOU are:

- a) To promote and enhance academic research and interest between KVK and AIET.
- b) To encourage bright students of AIET to execute major as well as mini projects under the expertise of KVK in the potential problem domains of Agricultural research.
- c) To promote research/continuing education activities such as Seminars and Technical Talks between the institutions in order to create an awareness among students towards agricultural industry.
- d) To organize joint- workshops and Faculty Development Programs with a focus on latest agricultural trends and technologies which can significantly help to obtain solutions to the intense areas of agricultural issues such as plant production, horticulture and soil science.

2. Technical Areas of Collaboration

- a) To Promote academic interaction by delivering special lectures and invited talks at AIET on the topics of relevance to agricultural industry and research.
- b) To facilitate short term training programs and Internships for students to create awareness about agricultural science.
- c) To provide necessary help in organizing workshops and FDPs at AIET for the enhancement of skills of faculty and students so that they can jointly work towards addressing the emerging needs of agricultural field.
- d) To support the project implementation of AIET students by means of providing infrastructural and research laboratory facilities.
- e) To enhance quality of education and research in terms of providing expert guidance in the intense areas of agricultural research.

3. Proposed Modes of Collaboration

KVK and AIET propose to collaborate through the following:

- a) Cooperation and promotion of research and training on agreed topics.
- b) Implementation of major and mini projects.
- c) Any other appropriate mode of interaction agreed upon between KVK and AIET.

4. Terms and Conditions

- a) For continuing education activities such as short term training programs, workshop to AIET faculty and students, the infrastructure facilities as well as financial arrangements will be made on mutually agreed terms.
- b) Usage of KVK laboratory facilities can be allowed for limited period subject to its availability, approval of Head of KVK and Institute norms.
- c) The Expert talks and seminars will be held at AIET and all basic infrastructure facilities such as class rooms related to the same will be provided by AIET.

- a) KVK and AIET agree to hold in confidence all information/ data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.
- b) The above confidential clause under this MOU excludes the information/ data possessed by either institute before entering into this MOU or independently developed and/or information already available through the public domain.

6. Duration of MOU
