

Dr. Peter Fernandes, Principal & Member Secretary, welcomed all members to the finance and purchase committee meeting. In the beginning, principal explained the reason for the delay in meeting that the institute was closed due to lockdown. The meeting which was supposed to be conducted in the month of May or June, is postponed to October.

Principal, with the assistance of Mr. Shantharam Kamath, Finance Officer, presented the details of the expenditure incurred in the institute for the financial year 2019 – 20 under various heads, such as infrastructure built-up, library, laboratory equipment, Research and development, placement activities, teaching and non-teaching salary and other consumable items, along with the audit statements.

As per the circular dated 03 August, 2020 (Ref. No: AIET/IQAC/2020-21/01), Heads of various department sent the budget requirement for the academic year 2020 - 21 to principal. Principal presented the consolidated budget requirement containing various heads, such as infrastructure built-up, library, laboratory equipment, Research and development, placement activities, teaching and non-teaching salary and other consumable items, in front of the committee for the approval.

After going through the documents and discussion with the Principal, committee approved the budget for the academic year 2020 - 21 to procure the various requirements for all the departments, library etc. Also, committee suggested including any expenditure which is necessary for the overall growth of the institute, in the next budget.

Also, it was decided in the meeting that, if the requirement exceeds upto 10% of the total sanctioned budget amount, then no further approval is required. If the requirement exceeds more than 10% of the total sanctioned budget, then approval is required from the Governing Council.

Meeting was concluded by the member secretary thanking all the members.
