Principal presented the facts to the members about various measures taken to inform, not only the concerned students, also their parents about the shortage of attendance. Even after the repeated counselling by the class coordinator, HoDs and Principal, the above mentioned students were not able to maintain the required percentage of attendance as prescribed by the VTU. Hence they had shortage of attendance and as per the VTU directions these students were not allowed to appear for the exams.

5. Discussion of even semester results of BE /MBA for the exams held during May/June-2017.

Principal presented the Even semesters results of BE & MBA for the exams held during May/June2017. Principal presented the various steps that are being adopted to improve the semester results such as providing special coaching classes for academically weak students, giving more attention to the weak students making small groups, boosting up their confidential level by counseling them timely etc. Finally the GC has expressed its satisfactory opinion and approved the results.

6. Financial Audit report for the financial year 2016 - 17.

Principal presented the audit report of the financial expenses for the financial year 2016 – 17 before the governing council and gave explanation about the expenditure occurred under various heads.

7. Revision of management fee structure

Chairman, after discussion with the members of GC decided to revise management fee structure. Chairman asked principal to produce the revised fee structure during the admission for the academic year 2018 – 19.

8. Developmental plans for the academic year 2018-19.

Principal proposed the following developmental plansfor the academic year 2018-19as discussed in the IQAC proceedings held on 12.01.2018:

a. Recruitment of Faculty as required.

b. Addition of books to the library as per the revised syllabus.

c. Establishment of Electrical Engineering lab for I year BE course.

Also, Principal produced a policy on IPR which was framed in IQAC meeting for the approval by the GC.

Principal brought to the notice of members of GC that Strategic Perspective Plan (SPP) for 2013-18 is getting expired by the end of 2018. As per the SPP 2013, the institute is having well established infrastructure to meet the academic needs of the students. Some departments obtained recognition as VTU Research centres. Principal explained the necessity to revise the Strategic perspective plan to adopt the new education system and to meet the needs of academic requirements. Principal presented the draft of Strategic Plan Advisory Committee (SPAC) details for the approval. Members of GC expressed good opinion about the implementation of SPP 2013 successfully. Also, approved the SPAC to come up with the SPP 2018 which takes institute to the next level in all aspects.

Finally, GC meeting was concluded with vote of thanks by the Principal.
