Dr. Peter Fernandes, Principal & Member Secretary, has warmly welcomed the members who have attended the meeting and presented the following activities for the grant of approval by the honourable GC members.

1. Revision of Vision & mission of the institute.

Since the institution has adopted Outcome Based Education(OBE) as per guidelines issued by the accreditation agencies, the Vision and mission of the Institution is reframed. The reframed statements were presented for the approval of GC and were approved.

2. Accreditation Process: NAAC and NBA.

It is need of the hour for all the institutions to get accredited by NBA to deliver Outcome Based Education (OBE). This system focuses on the skills and results achieved by the students as the most important aspect of education; Hence, Principal asked the permission of the GC members to submit the application for accreditation board, NBA. The GC members suggested applying for NAAC also. The committee members gave their consent to initiate the accreditation process, NBA and NAAC.

3. Establishment of Alva's Center for Advanced Research


The institute in its strive towards establishment of state-of-the-art research center, submitted a proposal to Karnataka State Council for Technological Up gradation (KCTU) for the development of chemical sensors. The proposal was approved by KCTU. In this regard GC members approved for establishment of "Alva's Centre for Advanced Research lab".

4. Revision of Service Rules, Responsibilities of various officials

The service rule was presented in front of the committee for any modification. Committee suggested some modifications in the service rules for the institute. Since the roles and responsibility of various officials were not included in the service rule, committee suggested including it in the service rule and republishing it. Also, principal brought to the notice of Governing Council that the management is providing incentives for funded projects and research activities. But the clause was not included in the service rule. Hence principal asked permission to include about the incentive in the service rule. Members of GC permitted to include the same and publish the revised service rules. Also, principal brought to the notice of the members that policy on code of ethics and handbook on human values and professional ethics is revised as per the requirement. GC members went through the revised copy and approved the same.

Principal presented the Strategic Perspective Plan 2018. Strategic Plan Advisory Committee - SPAC drafted Strategic Perspective Plan for fifteen years (2018-2032) by gathering inputs from various stake holders, which draws out action plan for achieving the Mission of the institute. After going through the SPP 2018, members of GC appreciated the goal set for the growth of the institute and approved the same.

Finally, GC meeting was concluded with vote of thanks by the Principal.
