The university approved the list of students and allotted University Seat Numbers (USN) to the students. Principal presented the list before the committee.

Governing council expressed its unhappiness towards the less admission in the institute. Also, suggested to take corrective measures to improve the admission.

2. List of students who had shortage attendance during odd semester of the academic year 2017 - 18.

The list of students, who had shortage of attendance in  $1^{st}$ ,  $3^{rd}$ ,  $5^{th}$  &  $7^{th}$  Sem BE and I & III Sem MBA for Dec 2018/Jan 2019 exams, was presented by the principal.

Principal presented the facts to the members about various measures taken to inform, not only the concerned students, also their parents about the shortage of attendance. Even after

the repeated counselling by the class coordinator, HoDs and Principal, the above mentioned students were not able to maintain the required percentage of attendance as prescribed by the VTU. Hence they had shortage of attendance and as per the VTU directions these students were not allowed to appear for the exams.

 Discussion of even semester results of BE /MBA for the exams held during May/June-2018.

Principal presented the Even semesters results of BE & MBA for the exams held during May/June2018. Principal presented the various steps that are being adopted to improve the semester results such as providing special coaching classes for academically weak students, giving more attention to the weak students making small groups, boosting up their confidential level by counselling them timely etc. Finally the GC has expressed its satisfactory opinion and approved the results.

4. Financial Audit report for the financial year 2017 - 18.

Principal presented the audit report of the financial expenses for the financial year 2017 – 18 before the governing council and gave explanation about the expenditure occurred under various heads.

5. Discussion on how to improve admission.
