conducting semester end examination. Hence there is no shortage of attendance to any students.

3. Discussion of even semester results of BE /MBA for the exams held during May/June-2019

Principal presented the Even semesters results of BE & MBA for the exams held during May/June2019. Principal presented the various steps that are being adopted to improve the semester results such as providing special coaching classes for academically weak students, giving more attention to the weakstudents making small groups, boosting up their confidence level by counselling them timely etc.

4. Financial Audit report for the financial year 2018 - 19.

Principal presented the audit report of the financial expenses for the financial year 2018 – 19 before the governing council and gave explanation about the expenditure occurred under various heads.

5. Additional course on "Artificial Intelligence & Machine Learning" &increase in intake for the CSE course
