List of students with attendance shortage in 1st, 3rd, 5th & 7th Sem. BE and I & III Sem. MBA to take up Jan/Feb 2021 exams.

The list of students, who had shortage of attendance in 1st, 3rd, 5th & 7th Sem BE and I & III Sem MBA for Jan/Feb 2021 exams, was presented by the principal.

Principal presented the facts to the members about various measures taken to inform, not only the concerned students, also their parents about the shortage of attendance. Even after the repeated counseling by the class coordinator, HoDs and Principal, students were not able to maintain the required percentage of attendance as prescribed by the VTU. Hence, they had shortage of attendance and as per the VTU directions these students were not allowed to appear for the exams.

3. Financial Audit report for the financial year 2019-20.

Principal presented the audit report of the financial expenses for the financial year 2019-20 before the governing council and gave explanation about the expenditure occurred under various heads.

4. Additional course on "Agriculture Engineering and Computer Science & Design" & decrease in intake for the Civil & Mechanical Engineering courses.

Principal proposed to start new course in Agriculture Engineering and Computer Science & Design and to decrease 30 seats in Civil Engineering and Mechanical Engineering due to low admission since last three years and the intake can be reduced to 90 in both the branches from the academic year 2021-22. Finally governing council agreed to start new course in Agriculture Engineering and Computer Science & Design and to decrease 30 seats in ME & Civil branch.

Members of GC suggested to that existing faculty from Mechanical Engineering & Civil Engineering can be designated to handle classes for Agriculture Engineering & Computer Science & Design courses.

Also, management suggested revising the fee structure for management seats which should be implemented from the academic year 2021 – 22.

5. Approval of e-Governance report

Principal brought to the notice of members of GC that institute isupdating e-Governance software to provide transparent, reliable, and efficient governance system in all its functional units. After detailed discussion on the report, the members approved the same.

6. Any other topics for the development of the college.

Principal proposed Prof. Harish Kunder as Head for the Artificial Intelligence and Machine Learning branch. The members of the committee agreed the proposal and approved to
