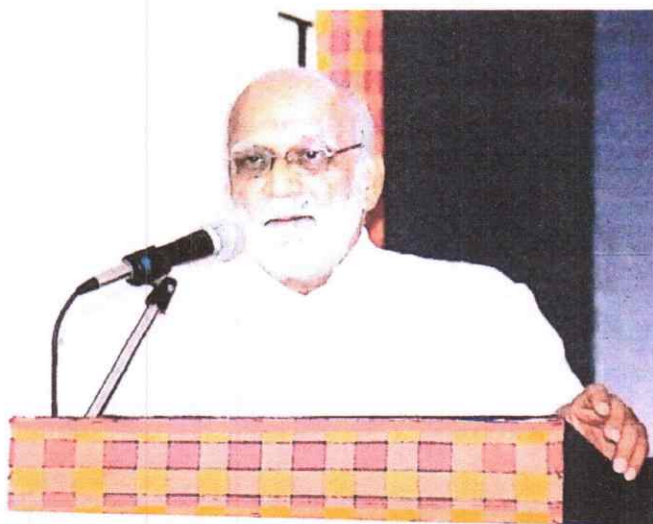
Dr. Peter Fernandes, Principal, AIET, Mijar, presided over the function. Mrs.
